- work according to instructions or directions and/or, in some cases, with the assistance of another person;
- work in compliance with technological regulations;
- use materials, energy, water and other substances and handle waste in an environmentally conscious manner;
- deal with issues related to maintaining his/her own household;
- use simple working procedures necessary for everyday life;
- be capable of performing specific work activities according to the practical specialisation of the school educational programme in which they have received training, which reflects regional requirements and capabilities of students.



4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Graduates from the one-year practical school can, with regard to their limits and individual abilities, be employed, depending on the specialisation of the respective school educational programme, in ancillary works in the field of services and production (e.g. in health care, in social and municipal services, in production plants, in agriculture), or at sheltered workplaces. Examples of possible job positions include: ancillary staff, household staff.
